## **Sanax Medical & First Aid Terms & Conditions Of Trading Agreement**

Conditions of sale apply to all our sale of goods contraction, any order placed with us constitutes your agreement to be bound by these terms. Any additional or different terms you stipulate or state in any communication with us (including and order) are hereby objected to and will not bind us unless we agree in writing. No salesman, representative or agent is authorised by us to give any guarantee, warranty or representation in addition to, or contrary to these conditions. In any event, receipt of good by you (or another as you direct) upon delivery constitutes your agreement to be bound by these terms.

1. All goods are sold subject to goods & services tax (GST) unless the goods are classified as GST exempt.
2. Terms are 30 days from the end of month of date of invoice unless otherwise notified in writing by Sanax.
3. Sanax reserves the right to charge an administration fee of 2% above the National Bank of Australia business bank overdraft rate on all accounts in arrears of our standard net terms in clause 2.
4. Sanax reserves the right to suspend the delivery of further goods if the terms of payment are not strictly adhered to by you.
5. Any expenses, cost or disbursements incurred by us in recovering any outstanding monies including debt collection agency fees or solicitor's costs shall be paid by the customer. Providing that those fees do not exceed the scale charges by that debt collection agency/solicitor.
6. We shall be entitled to charge for and recover from you on demand costs or loss occasioned by failure by you to collect or take delivery of the goods (as the case maybe) as and when agreed to and/or delay or interruption in the installation of goods caused or contributed by any act or omission on your behalf. Any such costs or loss shall include (but not be limited to) the cost of storage, labour, transportation and administration costs at our prevailing commercial rates.
7. We shall not be responsible for any part delivery or delay in delivery of the goods as a result of events occurring beyond our control. We shall not be in any way responsible for any consequences (direct or indirect) arising from such delay or non-delivery.
8. We shall deliver the goods by such carrier and such form of transport that we consider to be appropriate. We reserve the right to charge a delivery fee on any orders that we are delivering.
9. Where you specify the carrier and the means of carriages, we shall deliver the goods in the way specified, the cost of such carriage to be borne by you.
10. We will not accept return of goods for credit or exchange unless we have agreed prior. Return of goods will only be accepted for credit with 14 days of delivery.
11. Return freight will be at our cost only when error is on our part.
12. No return goods will be accepted by us (even if we have agreed to do so) if they have been tampered with by you or any other person and are not as new. If the goods are expressly sold on a non-return basis, or returned without prior approval they shall be returned to you at your expense.
13. Risk in the goods shall pass to you at the time they leave our warehouse.
14. The customer hereby acknowledges that the property and title to the goods does not pass to them until the customer has made payment in full of the purchase price and any other monies owing.
15. If the customer shall fail to make any payment due under the contract, or commit any other breach of any of the customer obligations under the contract, Sanax reserves the right to suspend your credit account with out further notice.
